Symposium on "Information Security and Intellectual Property (ISIP)" will be held on September 18 - 20, 2025 in Split, Croatia in the frame of the 33rd International Conference on Software, Telecommunications and Computer Networks (SoftCOM 2025), which is technically co-sponsored by the IEEE Communications Society (ComSoc). Accepted and presented papers will be published in the symposium proceedings.
